## **Dr. Karina Marshall Goebel Awarded the 2016 Fellows Scholarship**

The AsMA Fellows Scholarship Committee recently announced the winner of the 2016 Fellows Scholarship. Karina Marshall Goebel, Ph.D. won the scholarship for her presentation and publication of a manuscript on “Intracranial and Intraocular Pressure During Various Degrees of Head-Down Tilt.”



The \$2,000 AsMA Fellows Scholarship is funded by the AsMA Foundation and is presented annually to an AsMA member who is a student in an aerospace medicine residency program, graduate program in aerospace medicine (Master or Ph.D.), medical certificate or aerospace diploma course, or in a full-time education/training program in the allied fields of nursing, physiology, human factors, psychology, ergonomics, and engineering. Selection criteria include delivering a slide or poster presentation as first author at the AsMA Annual Scientific Meeting and then submitting a manuscript as first author for publication in AsMA’s Aerospace Medicine & Human Performance Journal based on the same topic and/or material covered in the slide or poster presentation. The winner is selected by the AsMA Fellows Scholarship Committee based on the highest scientific value, originality, quality and relevance of the applicant’s presentation and AMHP manuscript related to the field of aerospace medicine (including allied scientific disciplines). Special consideration is given to those applicants who are at an early stage in their career development.

Dr. Melchor Antunano chairs the Fellows

Scholarship Committee and reports that there are 16 candidates who are eligible for the 2017 Fellows Award. Fellows who are interested in helping evaluate the 2017 candidates should contact Dr. Antunano prior to the Annual Scientific Meeting.

## **Foundation Annual Financial Report**

Secretary/Treasurer Peach Taylor reports that the Foundation remains on solid financial footing for 2016, with total assets (including those held for several constituent organizations) of over \$377,000. Scholarships and awards made by the Foundation totaled \$7,250. There were \$21,319 in new donations, included the establishment of the Belland Fund to support the general awards work of the Foundation. Tufton Capital Management Company continues to provide independent, professional management of the investment portfolio for the Foundation assets to limit volatility and provide a sound foundation for the future of the Aerospace Medicine Association Foundation. This portfolio account grew over 9% over 2016. The outstanding growth provides the opportunity to expand awards, grants, and support for the Association over the next few years.

## Plans Finalized for the Richard B. "Dick" Trumbo Preventive Medicine Run/Walk in Denver

Plans are well underway for the Richard B. "Dick" Trumbo 5K Preventive Medicine Run/Walk to be held at 6:00 AM on Monday, May 1, at the Mile-High Trail in Denver's beautiful City Park. This will be a special year due to the recent death of Dr. Trumbo. Dick Trumbo personally supported and helped arrange the annual fun run held in conjunction with AsMA's scientific meeting. When he became ill and unable to attend the meeting, the annual run was dropped for several years. Starting with the meeting in Orlando, the Richard B. "Dick" Trumbo 5K Preventive Medicine Run/Walk has been held annually in honor of Dick, and his wife Peggy has continued the tradition of support. The event is supported by the Foundation through proceeds generated from the Richard B. and Peggy Trumbo and the Richard and Issy Jennings Endowed Funds.

AsMA executive director Jeff Sventek and the AsMA local arrangements team have finalized logistical support to get runners from the host Sheraton hotel to the race venue and back in plenty of time for opening ceremonies. A little additional training may be helpful for the higher altitude, but the sunrise should be spectacular and there should be a big field for the run/walk. Average temperature at run time is approximately 40 degrees with a range of 30-50 degrees F. so runners should prepare for cool temperatures.
