Foundation Celebrates Eighth Year

Since December 2006, the AsMA Foundation has functioned as an IRS approved 501(c)(3)organization to support the Aerospace Medical Association's educational and scientific mission. The primary purpose of the Foundation is to advance knowledge in aerospace medicine through the promotion of education, training, research, grants and awards based on achievement, potential for contribution to the field, or overall need. Based on the educational model, the initial target for support from the Foundation has been directed to those who are early in their careers. Recently, the purposes and objectives of the Foundation have been widened to facilitate many additional avenues of support for the Association such as addressing the needs of the international aerospace medicine community and those in disadvantaged locations.

To date, the Foundation has 5 endowed funds that support awards and events in perpetuity (Mohler, Goldenrath, Tredici, Davis, and Trumbo) and maintains educational funds for the Society of NASA Flight Surgeons, Space Medicine Association, and Aerospace Nursing Society. The Foundation through its general funds supports the AsMA Fellows Award. Melchor Antuñano and his Fellow's Scholarship Committee finalized the competitive evaluation process and selected Brandon Richard Macias, Ph.D. as the 2014 scholarship winner. His presentation and publication of a manuscript in *ASEM* were titled "Intraocular and Intracranial Pressures during Head-Down-Tilt with Lower Body Negative Pressure." Dr. Macias' studies were selected over a very large field of presentations/publications. He will be invited to attend the Fellow's Dinner as a guest in Florida on May 11, 2015.

The \$2,000 Fellows Award is funded by the AsMA Foundation and is presented annually to an AsMA member who is a student in an aerospace medicine residency program, graduate program in aerospace medicine (Master or Ph.D.), medical certificate or aerospace diploma course, or in a full time education/training program in the allied fields of nursing, physiology, human factors, psychology, ergonomics, and engineering. Winners are selected by the AsMA Fellows Scholarship Committee based on the high scientific value, originality, quality and relevance of the candidates' presentations and published manuscripts.

Foundation Continues Growth

Foundation treasurer, Peach Taylor, reports that Foundation assets, including restricted and unrestricted funds, at the end of 2014 were \$316,710. Of that total, \$63,300 are funds maintained for constituent or affiliate organizations. Foundation funds sustained an overall gain of \$34,049 from 2013. The awards and scholarships financed by the Foundation for 2014 totaled \$5,750. Foundation investments continued solid returns in 2014 with total realized and unrealized return averaging 6.8%. This portfolio is managed by Hardesty Capital Management with a long-term goal of steady income to fund scholarships, grants and awards, limit volatility, and provide some prospect for capital growth.
