#### **Mayo Clinic Studies Age in Neurosurgeons**

In a new Mayo Clinic Proceedings study on how old is too old to perform neurosurgery, most neurosurgeons disagreed with an absolute age cutoff, but half favored additional testing for neurosurgeons 65 and older. This study is the first to survey neurosurgeons on their attitudes toward ceasing practice and testing in late career. Training to become a neurosurgeon is a lengthy process—typically 4 years of medical school, 7 years in neurosurgical residency, and frequently an additional year of post-residency fellowship. Neurosurgeons may perform surgery on the brain, spine, or any part of the central nervous system. Of 4899 neurosurgeons surveyed, 1449 (30%) responded to an anonymous and confidential questionnaire. Most respondents, 938 (65%), were 50 and older. Because more than one-third of U.S. surgeons are older than 55, the issues raised in the study will be important to other surgical disciplines.

#### Human Solutions Presents First VR Room for Collection Coordination

ZReality GmbH and Assyst, a company of the Human Solutions Group, have developed the globally unique Digital Showroom (VR), a virtual meeting place for all those involved in collection development. Manufacturers, their dealers and suppliers can meet virtually to review sketches, make live alterations, specify products, and order directly from the room. In one possible scenario, a moderator conducts the VR meeting in the Digital Showroom. The participants put on VR glasses and enter a virtual room, where they see a virtual model. The moderator presents the collection and triggers the changing of the outfits. Questions are asked, alterations are suggested and documented, variants are shown, and orders are accepted, just like a face-to-face meeting. Human Solutions introduced a preview of the Digital Showroom at the PI Apparel in Berlin in late October. Visitors were able to participate in a live demonstration and experienced how future collections will be virtually coordinated with partners from all over the world.

#### ETC Announces Contract from European Auto Maker

Environmental Tectonics Corporation's (ETC's) Environmental Testing and Simulations Systems (ETSS) business unit announced the award of a contract to supply full vehicle test chambers to a major European based luxury automobile manufacturer. The test chambers will be used to perform various Noise, Vibration, and Harshness (NVH) tests in addition to other tests under extreme environmental conditions. These systems represent the latest technology to support future automotive research and development. ETC's NVH test chambers are used to test vehicle suspension while operating on a 4-poster automotive test system or roller shaker. Each chamber is designed to supply a range of temperatures from -40°C to 50°C and humidity from 10% to 90%. The chambers will include full spectrum solar simulation systems that simulate the effects of the sun on vehicles. ETC's test chambers are used to test either full vehicles or single components such as the chassis, engines, air-conditioning systems, etc. ETC's test systems designed for the automotive industry include environmentally controlled drive-in vehicle test chambers, combustion air supply systems, altitude chambers and simulation systems, A/C system test benches and calorimeters, engine development systems, and automotive emissions testing systems.

## NIOSH Presents Innovation Awards to Three Mining Companies

The National Institute for Occupational Safety and Health (NIOSH) Mining Program, in conjunction with the National Mining Association (NMA), recognized the efforts of Peabody Energy Corp., Kinross Gold Corp., and Freeport-McMoRan for developing new equipment or tools, or using existing technology in new ways. The three companies were awarded 2017 NIOSH Mine Safety and Health Technology Innovations Awards during NMA's Safety Award Ceremony in Washington, DC, in early November. Peabody Energy won in the coal category for its redesign of seat belt restraints in haul trucks; Kinross Gold won in the metal category for its redesigned strike hammer; and Freeport-McMoRan, also in the metal category, won for its use of new or adapted technologies to help protect their workers, including a novel use of drones. The NIOSH Mining Program invites nominations throughout the year for its awards series, which offers awards in four different sectors of the mining industry: metal, coal, industrial minerals, and stone, sand, and gravel.
